ORDER 2026

NOTICE is given that the Council on the 17th February 2026 made an Order in pursuance of its powers as contained in Sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 the effect of which is as set out in the Schedule below.

The Order will come into force on the 27th February 2026.

If any person wishes to question the validity of the Order or of any of its powers on the grounds that it or they are not within the powers conferred by the Act or that any requirements of the Act or of any instrument made under the Act has not been complied with, that person may, within 6 weeks from the date on which the Order is made, apply for that purpose to the High Court.

Cwmtawe Comprehensive School

Ffordd Parc, Ynysderw (South Side)

1.23 From its junction with the School Access Road for a distance of approximately 35 metres in an easterly direction.

Ffordd Parc Tawe (West Side)

1.24 From its junction with the School Access Road for a distance of approximately 30 metres in a northerly direction.

Schedule 2 – Prohibition of Waiting, Loading and Unloading At Any Time

Cwmtawe Comprehensive School

2.1 Ffordd Parc, Ynysderw (West Side)

From its junction with the north western kerbline of the School Access Road for a distance of approximately 50 metres in a north easterly direction.

2.2 Ffordd Parc, Ynysderw (West Side)

From a point approximately 50 metres north east of its junction with the north western kerbline of the School Access Road for a distance of approximately 11 metres in a north easterly direction.

2.3 Ffordd Parc, Ynysderw (West Side)

From a point approximately 66 metres north east of its junction with the north western kerbline of the School Access Road for a distance of approximately 67 metres in a northerly and westerly direction.

2.4 Ffordd Parc, Ynysderw (South Side)

From its junction with the western kerbline of Ffordd Parc Ynysderw (Exit Road from Car drop/off pick up area) to its junction with the eastern kerbline of Ffordd Parc Ynysderw (Exit Road from Bus drop/off pick up area), a distance of approximately 14 metres in a westerly direction.

2.5 Ffordd Parc, Ynysderw (South Side)

From its junction with the western kerbline of Ffordd Parc Ynysderw (Exit Road from Bus pick up/drop off area) approximately 74 metres west thereof.

2.6 Ffordd Parc, Ynysderw (East, North and West Sides)

From a point approximately 292 metres south east of its junction with the southern kerbline of A474 Herbert Street Bypass to a point approximately 25 metres north west, then a point approximately 76 metres west and then approximately 111 metres south, a distance of approximately 212 metres.

2.7 Ffordd Parc, Ynysderw (Roundabout)

The circumference of the roundabout situated between Ffordd Parc Ynysderw and Ynysderw Road, a distance of approximately 50 metres in total.

- 2.8 Ffordd Parc, Ynysderw (Access Road to Car pick up/drop off area) (North Side)**
From its junction with the western kerblines of Ffordd Parc Ynysderw to a point approximately 4 metres west thereof
- 2.9 Ffordd Parc, Ynysderw (Access Road to Car pick up/drop off area) (South Side)**
From its junction with the western kerblines of Ffordd Parc Ynysderw to a point approximately 8 metres west thereof
- 2.10 Ffordd Parc, Ynysderw (Access Road to Bus pick up/drop off area) (North Side)**
From its junction with the western kerblines of Ffordd Parc Ynysderw to a point approximately 7 metres north east thereof
- 2.11 Ffordd Parc, Ynysderw (Access Road to Bus pick up/drop off area) (South Side)**
From its junction with the western kerblines of Ffordd Parc Ynysderw to a point approximately 10 metres north east thereof
- 2.12 Ffordd Parc, Ynysderw (Exit Road to Car pick up/drop off area) (East Side)**
From its junction with the southern kerblines of Ffordd Parc Ynysderw to a point approximately 4 metres south east thereof
- 2.13 Ffordd Parc, Ynysderw (Exit Road to Car pick up/drop off area) (West Side)**
From its junction with the southern kerblines of Ffordd Parc Ynysderw to a point approximately 6 metres south east thereof
- 2.14 Ffordd Parc, Ynysderw (Exit Road to Bus pick up/drop off area) (North Side)**
From its junction with the southern kerblines of Ffordd Parc Ynysderw to a point approximately 8 metres south east thereof
- 2.15 Ffordd Parc, Ynysderw (Exit Road to Bus pick up/drop off area) (West Side)**
From its junction with the southern kerblines of Ffordd Parc Ynysderw to a point approximately 9 metres south east thereof

2.16 Ffordd Parc, Ynysderw (South Side)

From its junction with the south western kerbline of the School Access Road for a distance of approximately 50 metres in a south easterly direction.

ORDER 2026

The Neath Port Talbot County Borough Council in exercise of its powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

1. This Order shall come into operation on the 27th February 2026 and may be cited as the “Neath Port Talbot County Borough Council (Ffordd Parc, Ynysderw, Cwmtawe) (Revocation) (Prohibition of Waiting, Loading or Unloading at Any Time) Order 2026”.
2. (1) In this Order –

“Public Service Vehicle” shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981 and “local service” shall have the same meaning as in Section 1 of the Transport Act 1985;

“Universal Providers” means those operators of postal services who are licensed to provide all or part of a Universal Postal Service under the provisions contained in the Postal Services Act 2000.

(2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

(3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
3. The provisions contained in (Various Streets Neath Port Talbot – Schools) (Revocation) (No Stopping on School Entrance Markings, Monday to Friday 8am to 5pm) and (Prohibition of Waiting,

Loading or Unloading At Any Time) Order 2020 are hereby revoked only in so far as they relate to the sides and lengths of roads set out in Schedule 1 to this Order.

4. Save as provided in Articles 5 and 6 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait, load or unload at any time on the lengths of sides of roads set out in Schedule 2 of this Order.
5. Nothing in Article 4 shall render it unlawful to cause or permit any vehicle to wait on the lengths and sides of roads specified therein for so long as may be necessary to enable: -
 - (A) A person to board or alight from a vehicle;
 - (B) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely: -
 - (i) Building, industrial or demolition operations;
 - (ii) The removal of any obstruction to traffic;
 - (iii) The laying, erection, alteration or repair in or on land adjacent to the said lengths of sides of road of any sewer or any main pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus defined in the Telecommunications Act 1984;
 - (C) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
 - (D) The vehicle to be used by a Universal Service Provider for the purpose of delivering or collecting postal packets;
 - (E) Public Service Vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses;
 - (F) The vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.

6. The prohibitions imposed by Article 4 shall not apply to Police, Fire, Ambulance or other Emergency Service vehicles or to Local Authority vehicles when in pursuance of statutory duties or powers.

From its junction with the north western kerbline of the School Access Road for a distance of approximately 50 metres in a north easterly direction.

2.2 Ffordd Parc, Ynysderw (West Side)

From a point approximately 50 metres north east of its junction with the north western kerbline of the School Access Road for a distance of approximately 11 metres in a north easterly direction.

2.3 Ffordd Parc, Ynysderw (West Side)

From a point approximately 66 metres north east of its junction with the north western kerbline of the School Access Road for a distance of approximately 67 metres in a northerly and westerly direction.

2.4 Ffordd Parc, Ynysderw (South Side)

From its junction with the western kerbline of Ffordd Parc Ynysderw (Exit Road from Car drop/off pick up area) to its junction with the eastern kerbline of Ffordd Parc Ynysderw (Exit Road from Bus

drop/off pick up area), a distance of approximately 14 metres in a westerly direction.

2.5 Ffordd Parc, Ynysderw (South Side)

From its junction with the western kerblineline of Ffordd Parc Ynysderw (Exit Road from Bus pick up/drop off area) approximately 74 metres west thereof.

2.6 Ffordd Parc, Ynysderw (East, North and West Sides)

From a point approximately 292 metres south east of its junction with the southern kerblineline of A474 Herbert Street Bypass to a point approximately 25 metres north west, then a point approximately 76 metres west and then approximately 111 metres south, a distance of approximately 212 metres.

2.7 Ffordd Parc, Ynysderw (Roundabout)

2.9 Ffordd Parc, Ynysderw (Access Road to Car pick up/drop off area) (South Side)

From its junction with the western kerblineline of Ffordd Parc Ynysderw to a point approximately 8 metres west thereof.

2.10 Ffordd Parc, Ynysderw (Access Road to Bus pick up/drop off area) (North Side)

From its junction with the western kerblineline of Ffordd Parc Ynysderw to a point approximately 7 metres north east thereof.

2.11 Ffordd Parc, Ynysderw (Access Road to Bus pick up/drop off area) (South Side)

From its junction with the western kerblineline of Ffordd Parc Ynysderw to a point approximately 10 metres north east thereof.

2.12 Ffordd Parc, Ynysderw (Exit Road to Car pick up/drop off area) (East Side)

From its junction with the southern kerblineline of Ffordd Parc Ynysderw to a point approximately 4 metres south east thereof.

From its junction with the southern kerblineline of Ffordd Parc Ynysderw to a point approximately 9 metres south east thereof.

2.16 Ffordd Parc, Ynysderw (South Side)

From its junction with the south western kerblineline of the School Access Road for a distance of approximately 50 metres in a south easterly direction.
