The Neath Port Talbot County Borough Council in exercise of its powers under Sections 32, 33, 34, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “The Act of 1984”) and of all other powers it enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Amendment Order:-

1. This Order shall come into operation on the 1st day of April 2026 and may be cited as the Neath Port Talbot County Borough Council (Off-Street Parking Places) (Country Parks) (Amendment) Order 2026.
 - (1) Except where otherwise stated, any reference in this Order to a Numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
 - (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.

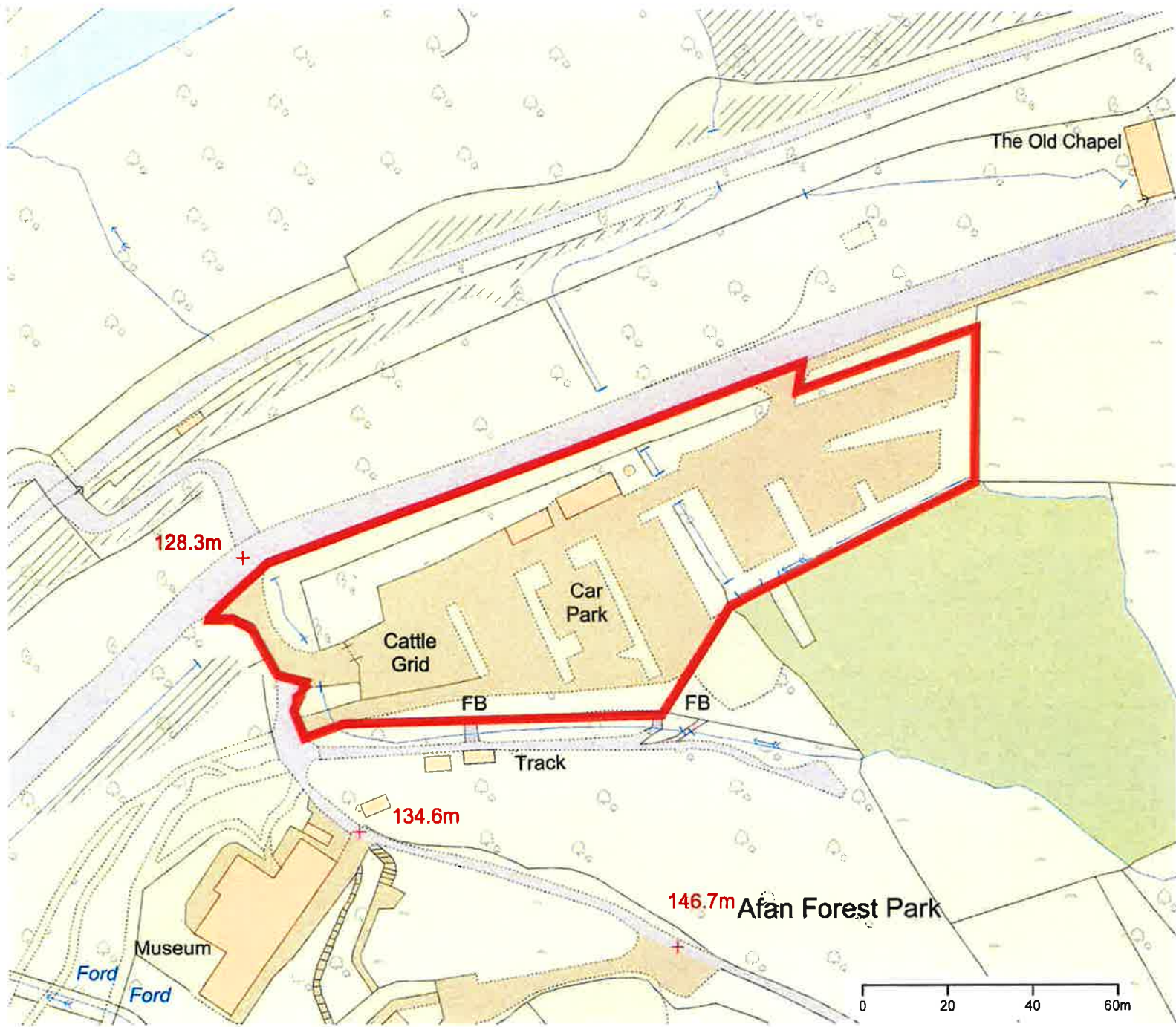
