#### **ORDER 2024**

The Neath Port Talbot County Borough Council in exercise of its powers under Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the Act of 1984) and of all other powers it enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby makes the following order:-

- 1. This Order shall come into operation on the 11<sup>th</sup> day of November 2024 and may be cited as the "Neath Port Talbot County Borough Council (B4242 Neath Road, Abergarwed) (Revocation) (40mph Speed Limit) Order 2024.
- 2. (i) Except where otherwise stated, any reference in this Order to a numbered article or schedule is a reference to the article or schedule bearing that number in this Order.
  - (ii) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- The provisions of all existing Speed Limit Orders made under the Road Traffic Regulation Act 1984 (or under any enactment which preceded that Act) are hereby revoked in so far as they relate to the length of road specified in the Schedule of this Order.
- 4. No person shall cause or permit any vehicle to be driven at a speed in excess of 40 miles per hour on the length of road specified in the Schedule of this Order.
