Informal Tender Procedures

1. If the Tender Procedures are not fully complied with, then the Tenderer may be disqualified from further consideration by the Authority, whose decision on the matter is final.

The Tender date is 12 noon, Tuesday, 4th August 2026

3. All offers must be submitted on the Informal Tender Form, which should be returned as outlined below.
4. The offer should be for a fixed sum (escalating or accumulating bids will not be considered). It is suggested that offers should be for an uneven figure to avoid identical offers.
5. All offers should give an indication as to whether they are subject to the sale of any other property or any special conditions.
6. An indication should be given as to the source and availability of the necessary finance to complete the purchase.
7. The successful party will be expected to exchange contracts within 60 days of being notified that their offer is accepted.
8. Details of the solicitor who will be acting on your behalf should be stated on the tender bid form.

9. Bids will be submitted to the Authority's board as soon as possible and they will endeavour to advise all persons who have made an offer as soon as instructions are received.
10. Prior to the closing date for Informal Tenders, the Council may issue amendments to clarify or modify these documents. A copy of each amendment will be issued to all persons in receipt of these documents and, for the avoidance of doubt, that amendment will become part of these documents.

Tenders are to be returned in an A4 envelope bearing the yellow 'tender' return label only. The envelope is to contain no information that will identify the Tenderer and must be returned to the Head of Legal Services at the Civic Centre, Port Talbot, SA13 1PJ before 12.00pm on the tender date. Any identifying marks will disqualify the Tender.

12. Where a courier or postal service is used, the Tenderer must instruct them not to mark the Tender with any mark which may identify the Tenderer. If this instruction is disregarded, the Tenderer will be responsible and the Tender will be disqualified.
13. If delivered by hand, Informal Tenders will only be accepted during the Councils normal office hours, which are 8.30 a.m. to 5.00 p.m. Monday to Thursday, and 8.30 a.m. to 4.30 p.m. Friday.
14. The identity of the Tenderer should be clearly stated on the Informal Tender Form. In the case of a private person, he or she must show his or her name and address in block capitals. In the case of a Limited Company, the name must be of the Company, the address must be the address of the Registered Office and the signature must be that of a Director or Secretary of the Company or some other person authorised to sign on behalf of the Company. In the case of a Charity or Unincorporated Association, the address must be

registered address, and the signature must be that of a duly authorised trustee or representative who is authorised to sign on behalf of the Charity or Unincorporated Association. If there is no such person authorised to sign, the Informal Tender shall be sealed by the Company/Charity/Unincorporated Association. In the case of a partnership, full names and addresses of all partners must be stated and the Informal Tender must be signed by all the partners.

15. No Informal Tender received after **12 noon, Tuesday, 4th August 2026 (time being of the essence)** will be considered by the Authority.
16. Offers transmitted by facsimile or email cannot be considered
17. The Authority does not undertake to accept the highest offer in respect of the property and shall not be liable for the Tenderer's costs in submitting a Tender.
18. The canvassing of any Member or Officer of the Authority or any of its representatives for the acceptance of any Tender will disqualify the Tenderer.
19. The Tender sum (i.e. the purchase price) must be completed in figures and words.
20. The Tender sum shall be for a sum of money in pounds sterling only and shall not make reference to any other currency or property.

- 21 Attention is drawn to the “Notice relating to the Freedom of Information Act 2000” attached to these Instructions. Tenderers **MUST** complete the portion at the end of the Notice and return the same **WITH** their Tender submission, thereby confirming that they acknowledge the provision of the Act and how the Act may apply to their Tender.
- 22 No unauthorised alteration or addition must be made to the Form of Tender, or any other component of the Tender documents. Tenders must not be qualified in any way, and must be submitted strictly in accordance with the Tender documents and these instructions. Tenders must not be accompanied by any covering letter or any statements that could be construed as rendering the Tender equivocal and/or placing it on a different footing from other Tenders.
- 23 All corrections which Tenderers may have made to the Form of Tender, or any other component of the Tender documents to be submitted must be initialled and dated by the person responsible for making the correction. For clarification purposes, correction fluid must not be used.
- 24 “The Anti-Collusion Certificate” attached to these instructions **MUST** be completed by the Tenderer and submitted **WITH** the Tender documentation.

This notice is to make Tenderers aware that the Freedom of Information Act 2000 came into force on 1st January 2005.
