ORDER 2026

The Neath Port Talbot County Borough Council in exercise of its powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby makes the following Order:-

1. This Order shall come into operation on the 28th day of September 2026 and may be cited as the “Neath Port Talbot County Borough Council (Ffordd Amazon, Crymlyn Burrows) (No Vehicles Except for Access to Off Street Premises) Order 2026”.
2.
 - (1) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
 - (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Save as provided in Articles, 4, 5, 6 and 7 of this Order, no person shall cause or permit any vehicle to proceed or be driven across those sides or lengths of roads as set out in the Schedule to this Order.
4. The prohibition imposed by Article 3 of this Order shall not apply to vehicles proceeding or being driven across those sides or lengths of roads set out in the Schedule to this Order for the purposes of obtaining access to land or premises situated on, under or abutting those lengths of roads.
5. The prohibition imposed by Article 3 of this Order shall not apply to Police, Fire, Ambulance or other Emergency Services or to Local Authority Vehicles when in pursuance of statutory powers.
6. The prohibition imposed by Article 3 of this Order shall not apply to Mechanical Cleansing Vehicles whilst engaged in street/drain cleaning operations on behalf of the Neath Port Talbot County Borough Council.

7. The prohibition imposed by Article 3 of this Order shall not apply to Refuge Vehicles whilst engaged in its refuge collecting operations on behalf of the Neath Port Talbot County Borough Council.

SCHEDULE

No Vehicles Except for Access to Off Street Premises

1.1 Ffordd Amazon, Crymlyn Burrows

From a point approximately 200m north east of its junction with Baldwins Crescent for a distance of approximately 1820 metres in a north easterly direction.
