

**NEATH PORT TALBOT COUNTY BOROUGH COUNCIL**

**(NEATH FOOD AND DRINK FESTIVAL 2025)**  
**(TEMPORARY ROAD CLOSURES AND SUSPENSION**  
**OF PEDESTRIAN AREA)**

**ORDER 2025**

**WHEREAS** the Neath Port Talbot County Borough Council (the “Council”) being the Traffic Authority for Neath Town Centre is satisfied that vehicular traffic on certain roads within the Town Centre should be restricted for the purpose of facilitating the holding of the annual Neath Food and Drink Festival 2025.

**NOW** therefore the Council in exercise of the powers conferred on it by Section 16A of the Road Traffic Regulation Act 1984 (as amended) and having obtained the consent of the Welsh Government in accordance with Section 16B of the aforesaid Act hereby make the following Order.

**IT IS HEREBY ORDERED THAT:**

1. Subject to the provision set out in clause 2 below, whilst this Order is in force, vehicular traffic are prohibited from driving along and parking on the lengths of roads set out in the Schedule to this Order.
2. The restrictions set out in clause 1 above shall not apply to the following vehicles:-
  - a) trading stall holders’ vehicles and/or goods delivery vehicles supplying the trading stalls
  - b) goods delivery vehicles which are carrying out deliveries to business premises situated on or adjacent to the roads set out in the Schedule below
3. Whilst this Order is in force the provisions set out in the Neath Port Talbot County Borough Council (Neath Pedestrian Area) Order 2015 are suspended.
4. This Order will come into force at 10.30am on Thursday 2nd October 2025 and shall continue in force until 11.59pm on Saturday 4th October 2025.
5. This Order may be cited as the “Neath Port Talbot County Borough Council (Neath Food and Drink Festival 2025) (Temporary Road Closures and Suspension of Pedestrian Area) Order 2025”.

**SCHEDULE**

**Temporary Road Closures**

**1.1 Green Street, Neath**

From its junction with Windsor Road to its junction with Orchard Street a distance of approximately 138 metres.

**1.2 Wind Street, Neath**

From its junction with Water Street to its junction with Orchard Street a distance of approximately 102 metres.

**1.3 The Parade, Neath**

From its junction with The Croft to its junction with New Street for a distance of approximately 25 metres.

**1.4 New Street, Neath**

From its junction with Angel Street to its junction with Wind Street a distance of approximately 87 metres.

**1.5 Angel Street, Neath**

From its junction with The Parade for a distance of approximately 86 metres in a north westerly direction.

**1.6 Cattle Street, Neath**

From its junction with New Street for a distance of approximately 100 metres in a north easterly direction

**1.7 Queen Street, Neath**

From its junction with Green Street for a distance of approximately 185 metres in a south easterly direction

**1.8 Orchard Street, Neath**

From its junction with Green Street for a distance of approximately 30 metres in a south easterly direction

**1.9 Church Place, Neath**

From its junction with New Street to its junction with Wind Street.
