 - (i) Except where otherwise stated, any reference in this Order to a numbered article or schedule is a reference to the article or schedule bearing that number in this Order.
 - (ii) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament
- 2. All existing Speed Limit Orders which are currently in place on the roads referred to in the Schedules are hereby revoked in so far as they relate to the lengths and sides of roads set out in Schedule 1 and 2 of this Order.
- 3. No person shall cause or permit any vehicle to be driven at speeds in excess of 30 miles per hour on the lengths of sides or roads specified in Schedule 1 of this Order.
- 4. No person shall cause or permit any vehicle to be driven at speeds in excess of 40 miles per hour on the lengths of sides or roads specified in Schedule 2 of this Order.

A4067 From Ynysymeudwy to Godrergraig

From a point approximately 188 metres in a south westerly direction from its junction with Graig Newydd for a distance of approximately 1145 metres in a south westerly direction.
